Property Taxes

Summer Tax Due Date is August 31, 2018

Property taxes are payable beginning July 1, 2018 and are due without penalty on or before August 31, 2018. A 4% administration fee will be added September 1, 2018, and interest of ½% per month will be added beginning October 1, 2018. Taxes can be paid from 8:00am to 5:00pm Mon.-Fri. at 227 E. Lincoln, Reed City, MI 49677.

Brush and Leaf Pick Up

The Department of Public Works is picking up brush, grass clippings and Leaves starting the 1st Monday of each month until November. The following are some guidelines for pick up.

- All MUST be separated. ie: Different piles for brush, grass clippings and leaves
- Brush must not exceed 4 inch diameter.
- Must be stacked in the boulevard (between the street & sidewalk).
- Leaves also must be piled in boulevard (separate from brush and grass)
- Please DO NOT bag the leaves, grass or brush
- NO Brush from tree removal.
- NO animal waste.



If these guide lines are not followed your brush & leaves will NOT be picked up and are subject to fines.



Hydrant flushing

On July 16, 2018 through July 20, 2018 from 7:00 a.m. until 3:30 p.m., the DPW will be flushing the city fire hydrants and doing valve maintenance exercises. This may cause rusty water so please use caution when washing clothes.

Step Forward Michigan Program

Osceola County is participating in a State program that can provide up to \$30,000 per homeowner to help with delinquent taxes or mortgages. County Treasurer Lori Leudeman recently announced the availability of the program called "Helping Michigan's Hardest Hit" program. Michigan has received nearly \$500 million in Emergency Economic Stabilization Act funds to operate the program and spread the aid among state citizens. The funds are available on a first come-first serve basis statewide. Osceola County has chosen to participate in the delinquent tax part of the program. Interested individuals may apply now with the state online at www.stepforwardmichigan.gov. Those without internet access may call Teagan Lefere at Clare Co MSU Extension 989-539-7805 for help with the application. A paper copy with a short description of the program is also available at the County Treasurer's office.

WINTER PARKING BAN

The City of Reed City will be enforcing the parking ban starting November 15, 2018 and ending April 1, 2019. This prohibits the parking of any vehicle on any street in Reed City between 2:30 A.M. – 6:00 A.M., or any City owned parking lots EXCEPT in the designated 24 hour parking areas.

This is in accordance with Chapter 126, Sec. 8.30 of the City Code. Chapter 131 Sec. 10.106 of the City code provides for a fine of \$30.00 for each violation, plus an impound towing fee if necessary to remove the vehicle.

REMEMBER... There is NO PARKING throughout the Upton Street business district between 2:30 AM – 6:00 AM year round!!! The Reed City Police Department enforces these regulations, not only for snow removal by the DPW, but to also ensure clear streets for travel by the public and emergency vehicles.
