CITY OF REED CITY ORDINANCE NO. 005-2019

AN ORDINANCE TO AMEND PART SIX, CHAPTER 656 PEACE DISTURBANCES

At a September 16, 2019 regular meeting of the City Council held at 7:00 P.M. at the City Hall, 227 East Lincoln Avenue, Reed City, Michigan 49677.

The City of Reed City ordains:

Chapter 656 of the City Code is amended to add Section 656.06 for the purpose of regulating the hours and days for igniting, discharging or using consumer fireworks and to provide penalties for violations as follows:

656.06

(a) AUTHORITY.

This Ordinance is hereby adopted pursuant to authority conferred upon local units of government by MCL 28.457.

(b) DEFINITIONS.

- "Consumer fireworks" means fireworks devices that are designed to produce visible effects by combustion, that are required to comply with the construction, chemical composition, and labeling regulations promulgated by the United States Consumer Product Safety Commission under 16 CFR parts 1500 and 1507, and that are listed in APA Standard 87-1, 3.1.1, 3.1.3, or 3.5. Consumer fireworks does not include low-impact fireworks.
- 2) "Low-impact fireworks" means ground and handheld sparkling devices as that phrase is defined under APA Standard 87-1, 3.1, 3.1.1.1 to 3.1.1.8, and 3.5.
- (c) IGNITION, DISCHARGE AND USE OF CONSUMER FIREWORKS.

Consumer fireworks shall not be ignited, discharged or used in the City of Reed City except on the following dates and times:

- 1) December 31 from 11:00 a.m. until January 1 until 1:00 a.m.
- The Saturday and Sunday immediately preceding Memorial Day (allowed only from 11:00 a.m. to 11:45 p.m. on both days).
- 3) From June 29 through July 4 (allowed only from 11:00 a.m. to 11:45 p.m. on each day).
- 4) July 5 from 11:00 a.m. to 11:45 p.m. if July 5 falls on a Friday or Saturday.
- 5) The Saturday and Sunday immediately preceding Labor Day (allowed only from 11:00 a.m. to 11:45 p.m. on both days).

A person who violates this subsection shall be responsible for a municipal civil infraction, punishable by a fine of \$1,000. Five hundred dollars of the fine collected under this section of the ordinance shall be remitted to the City of Reed City Police Department.

(d) OTHER VIOLATIONS.

- A person shall not ignite, discharge, or use consumer fireworks on public property, school property, church property, or the property of another person without that organization's or person's express permission to use those fireworks on those premises. "Property of another person" includes hotel and motel property, apartment property, and condominium property, where an owner, management company, or association has or retains authority and control over the use of the property or common areas. A person who violates this subsection is responsible for a civil infraction, punishable by a fine of up to \$1,000, as provided by the Act.
- A person who ignites, discharges, or uses consumer fireworks or low-impact fireworks while under the influence of alcoholic liquor, a controlled substance, or a combination of alcoholic liquor and controlled substance, is guilty of a state civil infraction, punishable by a fine of up to \$1,000; or if the violation caused damage to the property of another person, guilty of a misdemeanor punishable by imprisonment for not more than 90 days or a fine of not more than \$1,000, or both.
- A person who owns or is in charge of property who knowingly allows consumer fireworks to be ignited, discharged or used in violation of this subsection shall be responsible for a municipal civil infraction, punishable by a fine of \$1,000.
- (e) Notwithstanding the provisions of subparagraph (c) of this section, if the environmental concerns based on the Department of Natural Resources Fire Division criteria are elevated to extreme fire conditions or if the environmental concerns based on the Department of Natural Resources Fire Division criteria are elevated to very high for 72 consecutive hours, the City of Reed City Fire Chief, on consultation with the Department of Natural Resources, has the authority to enforce a no burning restriction that includes a ban on the ignition, discharge and use of consumer fireworks within a city. If a no burning restriction is instituted under this subsection, the Fire Chief shall ensure that adequate notice of the restriction is provided to the public. Not more than 24 hours after the fire condition is downgraded from extreme or very high fire conditions, the Fire Chief shall lift the restriction and inform the public that the restriction has been lifted in the same manner that the restriction was announced or made known to the public. A person who violates such a ban shall be responsible for a municipal civil instruction, punishable by a fine of \$1,000.

EFFECTIVE DATE.

This Ordinance shall be effective upon publication of either the Ordinance's full text or a summary of the Ordinance prepared by the City Attorney.

ORDINANCE DECLARED ADOPTED.

This ordinance was introduced on July 15, 2019, by Councilperson MEINERT. On the 16th day of September, 2019, upon the motion by Councilperson McKINNEY, and seconded by Councilperson BAILEY, this ordinance was adopted.

WHEREAS, the City of Reed City adopted the Michigan Local Agency Pavement Warranty Program on September 16, 2019;

WHEREAS, the City of Reed City agrees to consider a local pavement warranty on each project that includes \$2 million or more in paving-related items and includes any state or federal funds;

WHEREAS, the Local Agency Pavement Warranty Program law requires each city and village to report annually on each project that includes \$2 million or more in paving-related items and includes any state or federal funds, whether or not a warranty was utilized in the project;

WHEREAS, the City of Reed City agrees to implement the Michigan Local Agency Pavement Warranty Program consistent with the Guidelines for Local Agency Pavement Warranty Program document that was approved by the Michigan Department of Transportation in 2018; and which City of Reed City adopted Implementation Policy defines the City of Reed City's intent of its pavement warranty program;

NOW THEREFORE BE IT RESOLVED, the City of Reed City hereby agrees to implement the Local Agency Pavement Warranty Program and annually report in accordance with the law.
