Mayor Meinert called the meeting to order at 5:30 P.M. in Council Chambers, 227 E. Lincoln Avenue, Reed City, Michigan.

This pocket park will be a key feature of Reed City's downtown revitalization including outdoor recreation and gathering spot for community events.

Stephanie Boyce with Crossroads Recreation Commission, they are the group that spear headed the splash pad project. Crossroads Recreation Commission appreciates this opportunity the City of Reed City has. Crossroads Recreation Commission has been working hard on grants as well. They are working with Fleis & VandenBrink on downsizing the splash pad a little bit. More splash less flash, taking bump outs out of the plan and making it just a little simpler. They are trying to make these little changes to make the most out of space.

Rich Saladin commented that this is about the same grant the City had applied for last year. Rich has worked with Rick Stout and the Crossroads Recreation Connections to make some modifications to the plans. Also, renovation to the old brownfield building that is owned by the government. Another topic is acrylic ice for the ice rink as the ice rink was only useable for three days this winter with ways to make that feasible. There is more money available with CDBG grant than last year, last year was max of 1 million, this year is max of 2 million. Match is 10% so the bang for the buck is great. Rotary Club has approved donating all funds that they have raised from activities will go to this Crossroad Recreation Commission and the pocket park project. Rich is meeting with Spectrum Health, Andrea Leslie, Regional VP foundation, who is open minded about helping fund programs like this. Rick Stout feels incredibly positive this type of project will stand a good chance of getting this a now.
